- 4.2 To acquire, take over and run any other Educational schools and Colleges, Computer Training institute of the trusts with similar objectives.
- 4.3 To run Environment Protection Schemes, conduct research of courses, and create awareness, among the public by setting up environmental Institute and to carry out effective means and ways to protect the environment.
- 4.4 To establish Schools, colleges and Technical institute/s for the benefit of orphan children by providing them Boarding and Hostel facilities.
- 4.5 To conduct, organize and establish Adult Education centers to eradicate illiteracy.
- 4.6 To establish home for the old aged personnel and teach them handicrafts, painting and any other courses to make them to free self dependent.
- 4.7 To establish and run hostels for the students of the Trust and where possible to accommodate other students.
- 4.8 To purchase lands, sites, buildings and properties and other movable assets for and on behalf of the Trust.
- 4.9 To build, construct, maintain, repair, adopt and to improve or modify any building/s to and to equip the same with all the facilities on the buildings, site or land belonging to the leased or rented site or land as suitable to the Trust.
- 4.10 To lease, mortgage the Trust Own buildings or Own property/s for the benefit of the Trust.



- 4.11 To acquire by gift, purchase, exchange, lease or otherwise land and buildings, sites or other immovable property together with all rights appertaining thereto
- 4.12 To take on lease or mortgage any building, land, site or property and construct buildings-thereon which are exclusively belonging to the Trust.
- 4.13 To collect public opinion on Educational matters.
- 4.14 To publish Newsletters, Magazines, Television Channels and text books for the benefit of students and public.
- 4.15 To establish and maintain avenues for printing and circulating, disseminating materials conducive for Educational activities and advanced educational programs.
- 4.16 To conduct seminars and workshops and arrange conferences in the matters of Educational importance.
- 4.17 To sponsor and conduct research in the areas of Education, Environment and Ecology, Police Studies, Traffic Management, Public Administration and any matters which are useful for the public.
- 4.18 To offer / sponsor and grant scholarship, subsidies, stipends to the needy and deserving students, Educational institute/s irrespective of religion, caste, creed or community in trust or other Educational institutions.
- 4.19 To sponsor and award prizes and certificates of merit in competitions conducted by Trust's or other Institutions.
- 4.20 To give loans, scholarships, free ships and other monetary assistance to the Educational Institutions and needy students.
- 4.21 To get collaboration or to enter into Agreement with Foreign Schools, Colleges or Universities to offer their courses and conduct examinations in India. Also to represent them in India and in other parts of the World.
- 4.22 To contribute or donate or organizations and institutions or donate or Organizations and Institutions organizing and Conducting lectures, seminars and cultural festivals of rural and national importance.

4. 24. To donate, assist and support the Institutions having similar objective of this trust and also any other religious or charitable trusts with the objective of serving the society.

4.25 To contribute or donate funds to institution of charitable organizations engaged in philanthropy renovation and preservation of old monuments and buildings of historical national importance, Hindu religious temples.

4.26 To receive donations of any kind from societies Trusts, Individual persons, Institutions, Common or any other organizations subject to the Rules and Regulations governed as per Law.

4.27 To draw, make accept, endorse, discount and execute, sign, Issue and otherwise deal with cheques, certificate receipts Govt. securities, promissory notes of exchange or other instruments and securities, negotiable or transferable or not,

4.28 To open and operate Accounts by the chairman directly or he may authorize the Vic-Chairman of the Trust in Banks, Post Offices, other Financial Institutions to borrow loans, Funds, overdraft, Cash Credit, term loans from the Banks, Financial Institutions and other institutions or persons as the chairman and Vic-chairman deem fit and chairman and Vice Chairman will have the power to sign the documents and give security of trust properties while borrowing.

4.29 To establish recruitment division to help the outgoing students of the Trust Institutions and also the General Public.

4.30 To undertake and to do any other work of similar nature aforesaid and carry out any other work to promote the aforesaid objectives.

#### 5.0 TRUST FUND

5.1 The Founder Chairman cum Trustee hereby irrevocably transfers a sum of Rs.25,000/- to the Trust and it shall form the nucleus of the Trust.

5.2 All subsequent contributions that may be made by the Trustees and other donations, gifts, contributions or bequeaths that may be made to this Trust, by any other person from time to time shall vest with the Board of Trustees as Trust Fund and by the same shall. Be applied to promote the objectives of the Trust.

6.0 BOARD OF TRUSTEES The Board of Trustees shall consist of the following persons

SRI. ARJUN BONSLE will be the Chairman for the Board of Trustees for his life time

6.1 The Board of Trustees shall consist of five trustees who shall be permanent. Trustees shall be nominated by the 1<sup>st</sup> trustee and 2<sup>nd</sup> Trustees. The Chairman or the founder trustee shall have one extra casting vote and in case of majority decision.

6.2 Notwithstanding what has been stated in this clause any of the trustees may retire after giving one month's prior notice in writing of his/ her intention to do so to each of the other trustees for the time being and upon the determination of such intention, the trustee/s giving such notice shall ipso facto ceased to be in the trustees of the trust.

6.3 The Board of Trustees shall consist of minimum of three and maximum of five trustees. (But the chairman can appoint any additional members as trustees and in the absence of the Chairman; the Vice Chairman can have the similar power)

#### 7.0 Powers of the Board of Trustees

Without prejudice to the generality of the provision of this instrument of the Trust, the Board of Trustees shall have and may exercise all or any of the following powers.

7.1 To acquire properties by purchase, gift, exchange, lease or otherwise, land and buildings/ or other inmovable property, movable stocks, securities and shares together with all rights appertaining thereto.


7.2 To purchase lands, sites, building property and other movable/ Immovable assets for the Trust.



- 7.5 To lease, mortgage or sell the Trust buildings, land or property for the benefit of the Trust,
- 7.6 To take on lease or mortgage new building, land, site or property and construct buildings on it.
- 7.7 To manage the properties of the Trust.
- 7.8 To raise funds of the Trust by gifts, donations or otherwise.
- 7.9 To raise loans to receive money, securities, instruments, or any other movable and immovable, properties for and on behalf of the trust with or without security and repay the same.
- 7.10 To grant receipts, to sign and execute instrument, and to endorse or discount cheques or other negotiable instruments through its accredited agents.
- 7.11 To sue and defend all legal proceedings on behalf of the Trust.
- 7.12 To invest the money and funds of the Trust and to vary the investments as and when it may deem necessary or proper and at any time to sell, call in or convert into money the aforesaid instrument, any of time sell, call in or any part of them or any part thereof.
- 7.13 To accumulate the income of the Trust and to amalgamate the same with one corpus of the Trust and any income of the Trust not spent in a year unless otherwise determined by the Board of Trustees be deemed to be accumulated by the Trust.
- 7.14 To make suitable grants of money or other assistance to a university, Educational institution or other Society. Or Trust for the conducting or the prosecution of any research, investigation, study in a subject in which the Trust is interested.
- 7.15 To grant fellowships, scholarships, or any monetary assistance on such terms and conditions as they may prescribe to such persons as they may select for carrying on any research, investigation or study in matters which the Trust is interested.
- 7.16 To manage, lease, rent out, at such rent or lease as they may deem fit or sell, transfer or otherwise dispose off any movable or immovable property owned or leased by the Trust.
- 7.17 To receive, collect and enforce recovery of the money due to the Trust and grant receipts and discharge therefore.

- 7.18 To appoint, terminate, suspend and otherwise deal with the employees of the Trust.
- 7.19 To appear and act before all Governmental and other Public Authorities and Courts and Tribunals.
- 7.20 To incur expenses connected with the administration of the Trust.
- 7.21 To apply the properties and funds off the Trust for the, objective of the trust.
- 7.22 TO appoint as many committee or advisory councils for the achievement or the furtherance of the object of the Trust and to assign from time to time such functions and duties and delegate such powers as the Chairman trustee may deem fit in such committees or advisory councils.
7. 23 To appoint such and so many persons on such terms and conditions as they may deem fit for conducting the studies, investigation, research, teaching, or other work undertaken by the Trust.
- 7.24 To correspond with the institutions, scholars and organizations and to co-operate with them in matters relating to the work of the Trust.
- 7.25 To appoint delegates to represent the Trust to conferences, seminars, in India and abroad.
- 7.26 To hold lectures, seminars and to arrange for studies, guest lectures, conferences in such subjects and in such manner as they deem fit from time to time.
- 7.27 To receive donations of any kind from societies or persons or Institutions or Government agencies.
- 7.28 To delegate any powers (by the Chairman) as he can lawfully delegate to any other person and to execute such power/s as he may think fit for the purpose.
- 7.29 To convert, to call in or otherwise dispose of any of the investment comprised in the Trust property and reinvest or change the nature of any other investment contained therein.
- 7.30 To prove welfare, housing, transport facilities to the employees and to the full time Directors working for the administration of Trust objectives.
- 7.31 To make such rules and regulations from time to time for proper management and conduct of the affairs of the Trust and its properties and assets.

7.32 To help promote, contribute, take over any other society, trust body of institutions incorporated for the objects similar to those of the trust herein.

7.33 To let out, dispose any immovable property comprised in the Trust fund for such period and on such rent and such terms and conditions as the Chairman Trustee in his absolute discretion shall think and to obtain property or building on leasing on such terms may be deemed just and proper.

7.34 To enter into contract on behalf of the Trust and rescind them.

7.35 To Purchase acquire movable and immovable properties for the Trust can be in the name of the trust executed by the Founder Chairman SRI. ARJUN BONSLE or with prior permission by Vice-Chairman VANI ARJUN. Except the properties purchased in the name of the Trust, the Trustees can have or hold their individual properties acquired by them in their individual capacity and with their personal/Professional income. It is made it clear that those properties are nothing to do with the above trust.

7.36 ACCOUNTS OPENING AND OPERATION: The Chairman & Vice-Chairman of the Trust will have exclusive powers to open and operate Trust accounts in Banks, Post Offices, other financial institutions etc.,.

7.37 BORROWING THE FUNDS: To borrow loans, funds overdraft, cash credit, term loans from the Banks, financial institutions and other institutions or persons as the Board of Trustees deem fit and the Chairman & Vice-Chairman will have the power to sign legal documents.

7.38 Any decision taken by The Chairman & Vice-Chairman, at any trust meeting shall be valid binding and final on all the Trustees and power so vested in of exercisable by the said Trustees shall be valid-and binding on the trust.

7.39 The Board of Trustees will have powers to invest the funds in any manner as they think deem fit either in the movable or immovable properties.

#### 8.00 INVESTMENT OF FUNDS.

8.01 All moneys available or required to be invested shall be invested by the Trustees either in all or any of the investments authorized under the provisions of Section 13(1)(d) read with Section 11(5) of the Income Tax Act, 1961 or the Indian Trust Act, 1882 or any statutory modification or re-enactments thereof or in purchase of immovable property or otherwise or deposit with any bank or banks on such terms as to repayment of the principal sum and interest as the Trustees may think proper.

9.5 SRI.ARJUN BONSLE shall be the Chairman of the Trust for his life time Trust for the Founder Chairman SRI.ARJUN BONSLE will have powers to nominate the chairman in his place by a letter in writing IN FUTURE.

9.6 Subject to the Clause 10 .3 above the Chairman and Vic-Chairman may from time to time by an instrument in writing under their hands can terminate the services of the present Trustee or can appoint an additional Trustee or a new Trustee to fill a vacancy and such Trustee or Trustees shall hold office for the time mentioned by the Chairman.

9.7 Any trustee may resign on giving ONE month prior notice to the remaining Trustees. The Trustee/s are also entitled to form any number of Trusts or part of any additional Trust which may be for the welfare of the society in large.

9.8 Any trustee shall be deemed to have been discharged and his office shall become vacant on the happening of all or any of the following events.

a) If/he/she is found to be unsound mind by a court or competent authority.

b) If/he/she is adjudicated or if he/she applies to be so adjudicated.

c) Except the Chairman or the founder trustee & Vice-Chairman the other Trustees shall be deemed to have been discharged and his/her office shall become vacant if the remaining Trustees at a formal meeting pass a resolution by majority. (Which resolution shall not be opened to question) declaring that the said Trustee has acted in a manner prejudicial, to the interest of the Trust or his/her, continuance as a Trustee is considered otherwise undesirable.

d) There shall be a Chairman of the Board of Trustees. The said SRI.ARJUN BONSLE shall be the Chairman for his life time.

e) The said SRI.ARJUN BONSLE shall be entitled to nominate any person as Trustee to fill the vacancy arising on his/her resignation or death and such person shall be the Chairman of the Board and exercise of the powers of the Chairman. In the absence of any such nomination the Vice-Chairman shall be Chairman of the trust.

f) The Chairman shall exercise powers as may be reserved to him by the Board by the Board of Trustees and without prejudice to the generality of this clause the Chairman shall be entitled to review periodically the work and progress of the Trust and to issue directions for its development which shall be carried out by the Board of Trustees.

g) The powers exercisable by the office bearers namely the Chairman Vice-Chairman, Secretary and Treasurer shall be as follows.

#### 10.0 BOARD OF TRUSTEES OR OFFICE BEARES:

##### 10.1 CHAIRMAN

The Chairman is the supreme head of the Trust and shall preside over all the meetings of the Board of Trustees, sub-committees, ad-hoc committees etc. when both the Chairman and vice chairman are absent, the Secretary with prior permission from the Chairman, shall preside. The Chairman shall have powers to summon the meeting of the Board of Trustees, if the exigency of the situation so demands on emergency basis within 24 hours. (The Chairman is empowered to sign, execute and register important instruments legal documents relating to the affairs of the trust. The Chairman or With written permission from him, the Vic-Chairman is also authorized to open bank accounts, borrow money from banks and other financial institutions as and when required for the Trust.

##### 10.2 VICE CHAIRMAN:

The Vice Chairman shall assist the Chairman in the formulation of the schemes and activities and shall preside over the meetings of the Board in the absence of the Chairman.

##### 10.3 SECRETARY


She/He shall be the principal executive officer of the Trust and execute all the decisions and resolutions passed by the Board in the right earnest. He shall at all times keep the Chairman and the Vice Chairman informed of all the important developments and other activities.


##### 10.4 TREASURER

She/He shall in consultation with the Chairman or the Vice-Chairman convene the meeting and maintain a systematic record of the minutes of such meetings. She/He shall attend to all the matters of general administration in accordance with the directions of the Board of trust.

#### 11.0 MEETINGS AND BUSINESS TRANSACTIONS BY THE TRUSTEES:

11.1 The Quorum required for the meeting of the Board of Trustees shall be five. In the case of meeting adjourned for want of quorum, the members present shall themselves constitute the quorum, subject to a minimum of two.

11.2 All decisions of the Board of Trustees may be taken by a simple majority 2 except as expressly provided for otherwise herein. The final approval of the said decision shall be by the Chairman only.

11.3 The Chairman of the meeting shall be entitled to an extra casting vote in the event of equality of votes at meeting

11.4 At least one week's notice in writing shall be given for every meeting of the Board of Trustees, provided, however, that the Chairman shall have powers to convene meeting at shorter notice for transacting any business considered by him/her to be urgent.

11.5 Minutes of the Meetings and all Major transactions are to be recorded in the Minutes Book.

12.0 FRAMING/AMENDING OF RULES AND BYE-LAWS ; The Chairman of Trust may frame rules and Bye-Laws for the management of the Trust, its Institutions, properties, projects and the proceedings of the Trustees, and amend or rescind them as it deems fit.

13.0 ACCOUNTS AND AUDITIING: The Trust shall maintain true and correct accounts of all receipts and expenses and disposal of the funds and properties of the Trust and a correct record of their meetings and deliberations. For the purpose of Accounting, the year shall be 31<sup>st</sup> March, of every year. The accounts, shall be audited by a Chartered Accountant duly appointed.

#### 14.0 IRREVOCABILITY AND AMENDMENTS TO THE TRUST:

The trust hereby created is Irrevocable. The provisions of this deed may be amended if the Chairman and Vice Chairman of Trustees unanimously so decide. It is hereby made clear that the Chairman and Vice Chairman shall have power to make, from time to time all such amendments as may be required to secure recognition, exemptions and reliefs under the Income Tax Act or other fiscal laws or as may be found necessary for the smooth working of the Trust or for the purpose of seeking recognition, aid or affiliation to the institutions of the trust. Provided that the Charter of this Trust as an-Educational trust shall not be altered however no amendments to the Trust deed shall be made which may be prove to be repugnant to the provision of section 2(15), 11, 12, 13 and 80G of the Income tax Act, 1961 as amended from time to time amendments shall be carried out without the prior permission of the Chairman and Vice Chairman.


